Project Objectives & Deliverables

Objective

To analyse the waste management situation in each country.

To develop a set of recommendations to improve the implementation of the waste acquis and therefore of the management of waste.

To propose options for regional cooperation on the management of specific waste streams, in particular WEEE.

To check compliance with selected EC waste Directives.

To present the project results to the stakeholders.

Consultation with the stakeholders

- Consultation with key public and private sector reps. for different purposes (assessment of waste practices, Roadmaps, WEEE assessments etc.).

National contact for the project = National Coordinator for the ECRAN WG on Waste.

- Role = primary contact, for identifying other key persons, providing documents, circulating drafts for review etc.

Early involvement of national authorities & private stakeholders helps:

- to deliver the project efficiently,
- to deliver the project effectively,
- to generate ownership of the project's results.

Project Planning

- **Project period: Jan. 2015 – Dec. 2016.**
- **Initial meeting with national authorities: March-April 2015.**
- **National Waste Assessments.**
 - **1st draft: September 2015.**
 - **2nd draft: February 2016.**
 - **Final draft: September 2016 (following the National Workshops).**
- **National Workshops: April-June 2016.**
- **Regional Workshop: October 2016.**
- **Regional Report:**
 - **Draft: before the Regional Workshop.**
 - **Final: following the Regional Workshop.**

National Waste Assessments

1. Initial meeting with national authorities
2. Preparation of draft NWAs = analysis of national waste (incl. WEEE) situation.
3. Consultation on draft NWAs:
 - Key government representatives,
 - Key stakeholders of the private (waste) sector.
4. Preparation of draft Roadmaps
 - recommendations on measures to deal with (including indicative planning + budget for implementation)
5. Consultation with national waste authorities.
 - on the draft Roadmaps.
6. Organisation of 6 National Workshops.
 - to discuss the draft Roadmaps.
7. Finalisation of NWAs

Regional cooperation on WEEE

- 1. Assessment of the WEEE management situation in the region**
- 2. Projections for WEEE arisings.**
- 3. Identification of key elements of effective WEEE management systems.**
 - **through a review of existing systems in EU MS.**
- 4. Analysis of options for regional cooperation on management of specific waste streams, in particular WEEE.**
 - **mainly related to spatial distribution of infrastructure.**
- 5. Organisation of 1 Regional Workshop**
- 6. Finalisation of the Regional Report.**

Workshops

National Workshops

- **Objective:** to discuss the NWAs.
- **Location:** 1 per country.
- **Duration:** 1 day.
- **Format:** round table, to allow for a focused discussion.
- **Language:** national & English (simultaneous interpretation).
- **Participants:** max. 15 officials (national, regional & local) + selected private sector reps in the afternoon.

Regional Workshop

- **Objective:** to discuss regional cooperation, in particular on WEEE management.
- **Duration:** 1 day.
- **Language:** all national languages & English (simultaneous interpretation).
- **Location:** FYROM, Montenegro or Albania.
- **Participants:** minimal 4 officials/country.
